**MCLEAN CITIZENS ASSOCIATION RESOLUTION
SPA-87-D-074
Trinity United Methodist Church
February 1, 2006**

Whereas, Trinity United Methodist Church has filed an application for a Special Permit Amendment wherein it is seeking approval to expand the floor area of the church property, and

Whereas, the Church has proposed a new 21,200 square foot building that will include a 450 seat auditorium/meeting hall. In front of the building will be a memorial garden with columbarium walls, and

Whereas, the existing Nursery School will increase its capacity from 50 to 99 children ages 3 through 5 and will be relocated from the western side of the existing church building to the eastern side of the new building, and

Whereas, 244 parking spaces are provided for the Church (448 seats), and auditorium (450 seats) and Nursery School (99 children) and the traffic flow has been modified within the property, and

Whereas, the existing house on the eastern end of the property will be used as church office space and the existing driveway entrance from Dolly Madison Blvd will be closed off, and

Whereas, the church has proposed transitional screening along the eastern and southern perimeter, but has requested a waiver for transitional screening along the western (Buchanan Street) and northern (Dolly Madison Blvd) frontage, and

Whereas, the increase in traffic will not necessitate the need for a traffic light, according to a VDOT determination, but the church will construct a right-turn lane from Dolly Madison Blvd into Buchanan Street to facilitate ease of traffic flow into the property, and

Whereas, the hours of operations of the church facilities will not be changed.

Now, therefore, be it resolved that the McLean Citizens Association supports the proposed Special Permit Amendment, but recommends that a waiver not be granted for otherwise-required transitional screening on the Buchanan Street frontage, which is needed to provide a more appropriate appearance of the property from that perspective.

Resolution Regarding Repair and Enhancement of Walking Trails, Bridges and Bikeways in McLean Central Park February 1, 2006

Whereas, the Fairfax County Park Authority (FCPA) has the responsibility and authority for maintaining the public land along Dead Run between Ingleside Ave. and Earnestine St. to the east and west, and Old Dominion Dr. and Churchill Road to the south and north, defined by FCPA as McLean Central Park and the southern end of Dead Run Stream Valley Park, and known commonly and collectively as McLean Central Park; and

Whereas, McLean Central Park is a popular and well used recreational area for the citizens of McLean; and

Whereas, the network of walking trails, bridges and bikeways in McLean Central Park provides an important link between the residential communities west of the park and the McLean central business district east of the park; and

Whereas, the current condition of the walking trails, bridges and bikeways in McLean Central Park is in serious disrepair; and

Whereas, this condition discourages public use and creates potentially serious safety issues; and

Whereas, a County bond that allocated a significant amount of funds for the FCPA was approved by the citizens during the November 2004 elections; now therefore

Be it resolved, that the McLean Citizens Association urges that the FCPA work with the McLean Citizens Association to create a comprehensive plan and prompt schedule for the restoration and repair of the walking trails, bridges and bikeways in McLean Central Park; and

Be it further and finally resolved, that the McLean Citizens Association urges that the FCPA allocate an appropriate amount of funds from the recently passed bond and/or maintenance funds.

MCLEAN PLANNING COMMITTEE

Jim Turner described a project at the junction of Chain Bridge Road and Davidson. Trees have been removed in agreement with the residents of the nearby Stoneleigh subdivision. The MCA has also exercised input on how the project will be implemented. The lot area is 2.61 acres. It will consist of 26 attractive townhouses.

A Tennyson Drive building contravened Community Business Center (CBC) requirements and the owners have agreed to comply.

Reference was made to loud music under the canopy at the Exxon gas station in central McLean.

The Bank of America building is undergoing renovation. The drive-in canopy was too low for school buses. Bank planned to place a spar over the entrance to avoid further damage to the canopy but the MPC quashed the idea. The spar will now be placed to one side and be less visible.

Commercial development of the Firehouse has been mooted. President Turner asked Rosemary Ryan to request that Supervisor DuBois address the matter before the Board.

MCLEAN REVITALIZATION CORPORATION

Suggested uses for the \$20 million bond money: parking garage to replace the Verizon building; undergrounding of services; streetscape and pedestrian safety. It is intended to place bus shelters in front of the McLean Racquet Club, the Doctor's Building, Total Beverage and the Crown gas station.

Dan DuVal was elected MRC President. Lane Gabeler was elected Vice President.
